All Products must be signed for on delivery by an adult aged 18 years or over. If no one is at the address when delivery is attempted the products will be retained by us.

Delivery areas must be hand trolley assessable and downstairs delivery only.

Should you fail to be present for your delivery we are entitled to charge you in full price for the items contained in your order and the cost of delivery.

The products will be your responsibility from the time of delivery.
